

About NEP2020

National Education Policy envisions an education system rooted in Indian ethos that contributes directly to transforming India, that is Bharat, sustainably into an equitable and vibrant knowledge society, by providing high-quality education to all, and thereby making India a global knowledge superpower. The vision of the Policy is to instill among the learners a deep-rooted pride in being Indian, not only in thought, but also in spirit, intellect, and deeds, as well as to develop knowledge, skills, values, and dispositions that support responsible commitment to human rights, sustainable development and living, and global well-being, thereby reflecting a truly global citizen.

The New Education Policy is student centric and provides flexibility for multidisciplinary education. The Policy provides multiple entry and exit options to the students. The student can choose their Major and Minor subjects. Various options are provided to the student to select the subjects from Open and General Electives, Ability and Skill Enhancement and vocational skill courses. The students will be sensitized regarding Indian Knowledge System.

Of course, there are few challenges in the implementation of NEP2020 but the College is committed to implement the policy in spirit from academic year 2024-25. College is committed to take a step forward to make the holistic development of the youth by providing value and skill-oriented education to make them employable and knowledgeable, and this will become very well possible with Autonomous status of the College.

The National Education Policy 2020 (NEP 2020) in India brings several significant changes by following of Multidisciplinary Approach, Reduction in Content Overload by focusing on core concepts and critical thinking rather than rote memorization, Skill Development and vocational Education, Assessment Reforms, Inclusion and Equity, Research and Innovation, Internationalizations of education by encouraging collaboration and exchange programs between Indian and foreign institutions promoting global exposure and cross-cultural learning.

As per National Education Policy 2020, the Academic Bank of Credits (ABC) has been envisaged to facilitate the academic mobility of students with the freedom to study across the higher education institutions in the country with an appropriate 'credit transfer' mechanism from one program to another, leading to attainment a Degree/ Diploma/PG etc. Our institution has registered with Academic Bank of Credit.

UNDER GRADUATE PROGRAMME EXAMINATION PATTERN

- The undergraduate programme of the college is of three years integrated pattern, divided into six semesters with two semesters at each year.
- Each semester of under graduate programme will have Continuous Internal Evaluation, Semester End Examination and Practical Examination (B.Sc. Information Technology and B.Sc. Data Science).
- Continuous Internal Evaluation (CIE) (20/40 marks) 40% weightage will be distributed as follows:
- CIE I : Test (10/20 marks)
- CIE II (Project/Presentation/Fieldwork/Review/Tutorials/Assignment etc.) (5/10 marks)
- CIE III Class participation/Attendance (5/10marks)
- Semester End Examination (30/60 marks) -60% weightage
- Paper pattern as decided by respective Board of Studies
- Equal weightage to each module of the syllabus.
- ➤ **Practical Examination** (50 marks) 50% for B.Sc. Information Technology and B.Sc. Data Science.

Eligibility Criteria:

- As per ordinance number 0.6086 of University Of Mumbai.
- Every learner should attend the minimum criteria of the attendance to be eligible to appear for semester in examination.

> Passing Criterion

 40% (Combined passing in CIE, Semester End Examination and Practical Examination) subject to securing minimum 25 % in CIE and external examination.

> Minimum credits

14 credits in each semester to be eligible for admission in the next class

> Academic & Non-academic Credit and Marks Allocation

- Courses in Major vertical will be from Economics, Psychology & Sociology departments for B.A.

Distribution of Credits will be as under

- a) Major (Core) Subject comprising Mandatory and Elective Courses:
 - i. Minimum 50% of total credits corresponding to Three year UG Degree- Mandatory Courses offered in all years;
 - ii. 2 credit course on Major Specific IKS shall be included under Major;
 - iii. Elective courses of Major will be offered in the third and/or final year.
 - iv. Vocational Skill Courses, Internship/ Apprenticeship, Field Projects, Research Projects connected to Major
- b) Minor Subject: 18-20 Credits
 - i. The Minor subjects may be from the different disciplines of the same faculty of DSC Major (Core) or they can be from different faculty altogether.
 - ii. The credits of Minor subjects shall be completed in the first three years of UG Programme.
- c) Generic/Open Elective Courses (OE): 10-12 credits
 - i. It is to be offered in I and/or II year
 - ii. OE is to be chosen compulsorily from faculty other than that of the Major from the basket available.
- d) Vocational and Skill Enhancement Courses (VSEC): 14-16 credits
- Vocational Skill Courses (VSC): 8-10 credits, including Hands on Training corresponding to the VISION-COMMITTED AND PERSUASIVE EFFORTS TOWARDS HOLISTIC EDUCATION

New Delhi: Nearly 80% of the public health facilities in India do not meet the minimum essential standards for infrastricture, manpower, equipment and other benchmarks set by the govt. This emerged from a self-assessment exercise in which govt asked public health facilities from across the states and UTs covered under the National Health Mission (NHM) — a flagship scheme of the govt — to Ill in details such as the number of doctors, nurses or basic medical equipment they have.

There are over 2 lakh public healthcare facilities and only 20% of the ones that participated in the exercise scored 80% or higher which is needed to qualify as Indian Public Health Standards (IPHS) compliant. About 42% scored less than 50% while the rest, scored anywhere between 50 to 80%.

COLLEGE RULES & REGULATIONS GENERAL:

- 1. Every student must have valid Identity Card. The student must always carry the Identity Card. He has to present it whenever demanded by any authority of the College. No student will be allowed to attend lectures, tutorial, etc. without valid Identity Card.
- 2. Student must attend Lectures and Tutorials according to the time table on all working days of the college. Students must not remain absent from Lectures, Tutorials, Practicals and Examinations without Prior permission of the Principal. A minimum attendance of 75 % at Lectures as well as Tutorials and Practicals In each term is required under the University rules. Students are warned that if their attendance at lectures, practical and tutorials is unsatisfactory, their terms will not be granted in accordance with the University Ordinance in that respect.



- 4. Students must write Mobile / Contact Number in the application form.
- 5. The college will not be responsible for any claim under Freeship / Scholarship in case students do not submit the required documents within prescribed time period, notified by government or the claim is rejected by Govt. Such students will have to pay full fees of the academic year.
- 6. Minimum 75% attendance is compulsory for availing the facility of Scholarship/Freeship.
- 7. Only those students having course Certificate issued by Maharashtra State Govt. are eligible for freeeship / scholarship schemes. And those students having caste certificate issued by other than Maharashtra State Govt. or having caste certificate issued by Maharashtra State mentioning .Therein 'Migrant from Other State' are not eligible for Freeship/Scholarships schemes.
- 8. Students can only avail of any one scholarship or freeship from only one course or Department of Government Authorities.
- 9. Freeship/Scholarship is not applicable to OBC/SBC/VJNT/SEBC/EWS students of B.M.S., B.Sc. (IT) / M.Com. (Busi.Mgt.) Courses, as per the oral directives issued by Social Welfare Department from time to time.

RULES FOR REFUND OF FEES

(Vide University circular no.UG/412 of 2008 dt.11th September, 2008)

0.2859: Refund of Tuition, Development and all other fees after cancellation of admissions:

The candidates who have taken admission in undergraduate courses in Govt. colleges, in Govt. aided and unaided courses conducted by affiliated colleges, and recognized Institutions may request for refund of fees after applying in writing for cancellation of their admission to the course. The refund of fees as applicable shall be made on or before 30th day after the date of cancellation and thereafter by RTGS. The percentage of fee for the course shall be refunded to the candidate after deducting charges as follows:

NOTE:- The total amount considered for the refund of fees from the commencement of academic term of the courses includes the following:-

- 1) All the fee items chargeable for one year are as per relevant University circulars for different faculties (excluding the courses for which the total amount is fixed by other competent authorities.
- 2) The fee charged towards group insurance and all fee components to be paid as University share (including Vice- Chancellor fund, University fee for sports and cultural activities, E-charge, disaster management fund, Exam. fee and Enrolment fee) are non-refundable if payment is made by the college prior to the date of cancellation
- 3) Fee collected for Identity card and Library card, Admission form and prospectus, Enrollment and any other course specific fee are not refundable

- 4) All refundable deposits (Laboratory, Caution Money and Library etc.) **shall be fully returned** at the time of cancellation.
- 5) Provided that wherever admissions are made through centralized admission process for professional and/or for any other courses by other competent Authorities, the Refund Rules are applicable if specified by such authorities (as per the rules of relevant agencies) for the 1st year admission. In case of admission to subsequent years of the course, 0.2859 is applicable for cancellation of admission.
- 6) Provided further that this refund rule is concurrent with the rules and guidelines of other professional statutory bodies appointed for admission for relevant courses.

NOTE:-

- 1) Student should submit self-attested zerox copy of their PASS BOOK
- 2) Refundable deposits if NOT CLAIMED by the concerned student within ONE CALENDER YEAR from the date on which he / she ceases to be on the roll of the college, WILL LAPSE IPSO-FACTO
- 3) Deposits will not be refunded, if dues to the college, are not cleared by the student, on account of breakage of laboratory equipment, damage done to any college property, loss of liability books, etc.

Refund of Fees will be made only by RTGS into Student's Account.
